Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

**Investigation of zebra mussel content**

**1** The Minister of the Environment, Conservation and Parks shall, under the provisions of subsection 15 (1) of the *Ontario Water Resources Act*, direct an investigation into the extent of the zebra mussel problem in the waterways specified in the Schedule.

**Commencement**

**2** This Act comes into force on the day it receives Royal Assent.

**Short title**

**3** The short title of this Act is the *Zebra Mussel Scan Act, 2018*.
