The Chair (Mr. Garfield Dunlop): Okay, we'll call the meeting to order. We have already explained, previous to this, exactly what's happening here. I'm going to go right over to—

The Clerk of the Committee (Mr. Trevor Day): Five is withdrawn.

**The Chair (Mr. Garfield Dunlop):** Subsections 5 through 12: Shall they carry? Carried.

Section 13, on page 6—

Interjection.

**The Chair (Mr. Garfield Dunlop):** Subsection 13(2) of the bill: Will it carry?

Interjection.

The Clerk of the Committee (Mr. Trevor Day): It's government motion 6, subsection 13(2) of the bill.

**Mr. Rob Leone:** Chair, are we voting on each individual section, even though there's no amendment, or are they deemed carried?

The Clerk of the Committee (Mr. Trevor Day): The votes can be voted on each section. If a member wants them spread out—the Chair, in the last one, grouped 5

through 12 as one vote, because there are no amendments.

Mr. Bas Balkissoon: Moved.

The Chair (Mr. Garfield Dunlop): NDP motion 59.

Mr. Peter Tabuns: Withdraw.

Mr. Peter Tabuns: Withdraw.

**The Chair (Mr. Garfield Dunlop):** Withdrawn. We'll now go to section—I'm sorry.

The Clerk of the Committee (Mr. Trevor Day): This is when the ordering changes a little bit.

**The Chair (Mr. Garfield Dunlop):** Yes, excuse me. We've got to get a clarification here from Trevor.

Section 50, which is NDP motion 71.

Mr. Peter Tabuns: Withdraw.

The Chair (Mr. Garfield Dunlop): Withdrawn. Shall section 50 carry? Carried.

Government motion 72.

Mr. Bas Balkissoon: Moved.

The Chair (Mr. Garfield Dunlop): It's moved. Government motion 72, subsections 51(2) of the bill, paragraph 4(2)4 of the Public Sector Compensation Restraint to Protect Public Services Act, 2010: in favour of that? Carried.

Shall section 51, as amended, carry? Carried.

Shall sections 52 to 55 carry? Carried.

Shall the title of—

The Chair (Mr. Garfield Dunlop): Oh, yes. Right.

The Clerk of the Committee (Mr. Trevor Day): We're now going to go back to the recorded votes. If any member would like a 20-minute recess?

Mr. Peter Tabuns: Just about got it.

**The Chair (Mr. Garfield Dunlop):** Those in favour of NDP motion 46?

The Chair (Mr. Garfield Dunlop): That doesn't mean I'm switching to your party, you know.

Interjections.

The Chair (Mr. Garfield Dunlop): Okay. That's enough of that nonsense. We're going to the very back here.

Mr. Bas Balkissoon: We'll renew your contract. The Chair (Mr. Garfield Dunlop): Yeah, right.

Shall the title of the bill carry? Carried.

Mr. Rob Leone: Recorded vote.

The Chair (Mr. Garfield Dunlop): Shall Bill 122, as amended, carry?

Mr. Rob Leone: Recorded vote.

The Chair (Mr. Garfield Dunlop): Recorded vote? Those in favour—

Mr. Bas Balkissoon: Is the bill carried?

The Clerk of the Committee (Mr. Trevor Day): No. We have a recorded vote request on the bill, as amended, carrying.
