The committee met at 0900 in room 151 and by video conference.

The Chair (Mr. Logan Kanapathi): Good morning. The Standing Committee on Regulations and Private Bills will come to order.

We have the following member in the room: MPP Dave Smith. Thank you for being here. The following members are participating remotely: MPP John Fraser; MPP Vincent Ke; MPP Billy Pang; MPP Jeremy Roberts; MPP Daisy Wai; MPP Jamie West; and MPP Mike Harris. Did I miss anyone? No?

We are also joined by staff from legislative research, Hansard, and broadcast and recording.

Please speak slowly and clearly and wait until I recognize you before starting to speak. Since it could take a little time for your audio and video to come up after I recognize you, please take a brief pause before beginning. As always, all comments should go through the Chair. Are there any questions before we begin?

COMMITTEE BUSINESS

The Chair (Mr. Logan Kanapathi): Seeing none, on the agenda is committee business. Are there any motions? MPP Dave Smith.

Mr. Dave Smith: I move that the committee enter closed session for the purposes of organizing committee business and that broadcasting staff be permitted to remain in the closed session meeting for the purposes of operating the electronic meeting technology.

The Chair (Mr. Logan Kanapathi): Thank you. Are there any—okay, there is a raised hand. MPP Jamie West.

Mr. Jamie West: Thank you, Chair. We've found a disturbing trend on our committee, where we're supposed to be representatives of the public—and successive business, every time we meet off scheduled time, is to do an in camera closed session. Given the agenda for this meeting is "committee business, recess, committee business," for an outsider to understand what's going on at Queen's Park, where we represent our constituents—all they know is, we had committee business and then we went into hiding to discuss things internally and then recessed, and then maybe this afternoon's committee business will have a different name. But I prefer to be transparent with the public about what we're doing and forward with the public about what we're doing.

The Chair (Mr. Logan Kanapathi): MPP Dave Smith.

Mr. Dave Smith: As MPP West knows—he is on subcommittee with me. Traditionally, in the past, subcommittees have met in camera to discuss committee business. Committee business, when we're discussing it, is organizing the committee so that we can bring forward bills or do planning for the schedule of what the committee is going to be. There is nothing that is being hidden in there—there never has been. And MPP West knows well, as a subcommittee member with me, that is what we have done in the past. We have changed that process so that the committee as a whole is meeting to discuss that business, to set up the schedule, so that all of the members have an opportunity to weigh in on it. I'm very disappointed that MPP West would suggest something that may not be 100% accurate.

The Chair (Mr. Logan Kanapathi): MPP West, again. Please go ahead.

Mr. Jamie West: Just for the record, when we're in camera—I'm not allowed to discuss what we discuss in camera, and so that sort of takes away my ability to review what's happening or even debate or discuss my perspective on how I see it in that perspective.

I'm not talking about that what we're doing is wrong; what I'm saying is, the appearance of us representing the public while always going in camera is not an appearance I'm proud of—and that's something that I'll support wholly. I'll vote against this. You have a majority; you'll vote it through. It will happen, just like every other time. I'm just putting on record that I think the way we're doing business is not something that the public would support. I think the public would support something more transparent and more public.

The Chair (Mr. Logan Kanapathi): Is there any further debate? Seeing none, are you ready to vote? I'm going to ask all those in favour to please raise your hand. Anyone opposed? Motion carried.

The committee continued in closed session at 0905 and resumed at 1500.

The Chair (Mr. Logan Kanapathi): Good afternoon, everyone. I call this meeting to order.

We have one member in the house: Dave Smith.

I'd like to confirm—I think there are a couple of MPPs who joined this meeting.

MPP Will Bouma, please confirm that you're present and are currently in Ontario.

Mr. Will Bouma: I am Will Bouma, and I'm in my office at Whitney Block.

The Chair (Mr. Logan Kanapathi): Thank you.

MPP Andrea Khanjin, please confirm that you're present and currently in Ontario.

Ms. Andrea Khanjin: I'm MPP Khanjin, and I'm in Ontario.

The Chair (Mr. Logan Kanapathi): I think that Daisy Wai is already confirmed. Okay.

We are joined by Bradley Warden from legislative counsel, as well as staff from Hansard and broadcast and recording.

To make sure that everyone can understand what is going on, it is important that all participants speak slowly and clearly. Please wait until I recognize you before starting to speak. Since it could take a little time for your audio and video to come up after I recognize you, please take a brief pause before beginning. As always, all comments should go through the Chair, please.

When we do a vote during today's meeting, it will be through a show of hands. Unless someone specially asks for a recorded vote after I have asked whether the members are ready to vote, the breakdown of the vote won't show up in Hansard. If there are any members who are calling in by phone or who don't have video capability, we will proceed with roll call votes.

Are there any questions before we begin? Seeing none, there are four private members' public bills on the agenda today for clause-by-clause consideration.
