REDUCING INEFFICIENCIES ACT (INFRASTRUCTURE STATUTE LAW AMENDMENTS), 2023

Consideration of the following bill:

Bill 69, An Act to amend various Acts with respect to infrastructure / Projet de loi 69, Loi modifiant diverses lois sur les infrastructures.

The Acting Chair (Mr. Lorne Coe): Good morning, committee members. Thank you for the nomination.

We're here to conduct clause-by-clause consideration of Bill 69, An Act to amend various Acts with respect to infrastructure. We are joined this morning by staff from legislative counsel, Hansard, and broadcast and recording. Please wait until I recognize you before starting to speak. And as always, all comments should go through the Chair.

Are there any questions, committee members, before we begin?

Are there any comments or questions to any section or schedule of the bill, and if so, to which section? Seeing none, we'll now begin clause-by-clause consideration of the bill.

Bill 69 is comprised of three sections which enact two schedules. In order to deal with the bill in an orderly fashion, I suggest we postpone those three sections in order to dispose of the schedules first. Committee members, is there agreement on this? We're all good? All right.

Moving then, committee members, please, to schedule 1, Environmental Assessment Act: There are no amendments to sections 1 to 4 of schedule 1. I propose we bundle them. Agreed? Thank you. Is there any debate? I see none. Are the members ready to vote? On sections 1 to 4: All those in favour? Opposed? Duly noted. Sections 1 to 4 are carried.

Schedule 1: Is there any debate on schedule 1? I don't see any. Are members ready to vote on schedule 1? All those in favour? Opposed? Schedule 1 is carried.

Schedule 2: There are no amendments to sections 1 to 12 of schedule 2. I propose that we bundle them. Agreed? Thank you. Is there any debate? I don't see any debate. Are members ready to vote? On sections 1 to 12 of schedule 2: All those in favour? Opposed? Sections 1 to 12 of schedule 2 are carried.

We are now on schedule 2, Ministry of Infrastructure Act, 2011. Is there any debate? I don't see any. Are members ready to vote? All those in favour of schedule 2, Ministry of Infrastructure Act, 2011? Opposed? Schedule 2, Ministry of Infrastructure Act, 2011, is carried.

We're now on sections 1 to 3 of the bill.

Section 1: Is there any debate? Seeing none, are the members ready to vote? All those in favour? All those opposed? Section 1 is therefore carried.

Section 2: Is there any debate? Seeing none, are members ready to vote? All those in favour of section 2? Opposed? That section is accordingly carried.

Section 3: Is there any debate? Are members ready to vote? All those in favour? All those opposed? That section is accordingly carried.

Shall the title of the bill carry? All those in favour? Opposed? The section is accordingly carried.

Shall Bill 69 carry? All those in favour? Opposed? The bill is accordingly carried.

Shall I report the bill to the House? All those in favour? Opposed? That is carried.

There being no further business, the committee now is adjourned. Thank you, committee members, for your attention. Have a great afternoon.
