The Chair (Mr. Steve Clark): We'll reconvene clause-by-clause. Now that we've finished Bill 137, we'll begin clause-by-clause for Bill 66.

Under standing order 83, are there any brief comments that anyone has on the bill before we proceed? MPP Gélinas.

M^{me} France Gélinas: It was super interesting listening to what the member has done—those ideas with the stethoscope clinics and to bring things forward. I think we have an opportunity to really educate people to take better care of their health. We have an opportunity to really focus on health promotion and disease prevention with that bill. I hope that it makes it to the finish line and becomes law.

The Chair (Mr. Steve Clark): Any other comments? Yes, MPP Martin.

Mrs. Robin Martin: I just wanted to comment that I find myself in the happy position of agreeing fully with everything Madame Gélinas said.

The Chair (Mr. Steve Clark): Excellent.

Okay, if there are no other comments, we'll move to clause-by-clause consideration. We have two amendments that have been distributed to members.

We'll move to section 1. Shall section 1 of the bill carry? Carried.

Section 2: There's an amendment. MPP Martin.

Mrs. Robin Martin: The amendment number 1 that was submitted last night I'd like to withdraw.

The Chair (Mr. Steve Clark): Okay.

Mrs. Robin Martin: Second amendment: I move that section 2 of the bill be amended by striking out "second Monday of September" and substituting "third Monday of September".

The Chair (Mr. Steve Clark): Thank you. Any discussion? Shall the motion carry? Carried.

Shall section 2, as amended, carry? Carried.

With concurrence of members, I'll group sections 3 and 4 together. That's okay? Shall sections 3 and 4 carry? Carried.

We'll now move to the preamble, and there is an amendment. MPP Martin.

Mrs. Robin Martin: I move that the preamble to the bill be amended by striking out "The second full week of September is recognized" and substituting "The third full week of September will be recognized".

The Chair (Mr. Steve Clark): Is there any discussion? All those in favour? Carried.

Shall the preamble carry, as amended? Carried.

Shall the title of the bill carry? Carried.

Shall Bill 66, as amended, carry? Carried.

Shall I report the bill, as amended, to the House? Carried.

I want to thank Hansard and our legislative counsel Bradley Warden for being here today. As always, I want to thank the Clerk and broadcast and, most importantly, I want to thank all of you.

Our business is done; meeting adjourned.
