## ELECTION OF CHAIR

**The Clerk of the Committee (Ms. Tanzima Khan):** Good afternoon, everyone. Welcome to the Standing Committee on Heritage, Infrastructure and Cultural Policy.

## APPOINTMENT OF VICE-CHAIRS

**The Chair (Ms. Laurie Scott):** Good afternoon, everyone. Thank you for electing me as Chair.

Standing order 119(e) states that where the Chair is a member of the government party, the First Vice-Chair shall be a member of the party forming the official opposition and the Second Vice-Chair shall be a member of a recognized party in opposition to the government other than the official opposition.

With that, it is my duty to call upon you to appoint a First Vice-Chair. Is there a motion? MPP McKenney.

**MPP Catherine McKenney:** I move that MPP Guy Bourgouin be appointed as Vice-Chair.

**The Chair (Ms. Laurie Scott):** A motion has been moved by MPP McKenney. Is there any debate? Seeing none, are the members ready to vote? Okay. Shall the motion carry? All those in favour, please raise your hand.

All those opposed, please raise your hand. I declare the motion carried.
