Mr. Hudak – That, in the opinion of this House, the Ministry of Natural Resources should create and fund a shared cost gypsy moth spraying program to circumvent the ongoing spread of moth-infested trees and woodlots causing damage to personal property, parks, and the environment, with municipalities that have demonstrated a need or interest such as Hamilton and Niagara. Filed on December 10, 2007.

6. Mr. Arnott – That, in the opinion of this House, the Government of Ontario should over a twelve-year period assume responsibility for all municipal bridges in Ontario, ensuring that these all-important links between communities are properly maintained. Filed on December 11, 2007.

7. Mr. Hampton – That, in the opinion of this House, as a noble tribute to those who served in the Great Wars, the Government of Ontario give consideration to providing financial support for urgently needed repairs to the Rose Window, in the Church of the Epiphany in Woodstock, which has stood as a tribute to our fallen heroes for the past 75 years. Filed on December 11, 2007.

8. Mr. Wilson – That, in the opinion of this House, the Government of Ontario should support the Town of New Tecumseth and the Sir Frederick Banting Legacy Foundation by ensuring that the recommendations made by the Conservation Review Board on the future of the Sir Frederick Banting Homestead in Alliston are enacted and that the Government of Ontario should take every measure necessary to ensure that this property is transferred to either the Town of New Tecumseth or the Sir Frederick Banting Legacy Foundation for the purpose of creating an educational and interpretative centre on a not-for-profit basis, such as a camp for diabetic youth, and to ensure that the property is properly maintained. Filed on December 12, 2007.

9. Mr. Barrett – That, in the opinion of this House, the following Order of Reference should be assigned to an all-Party committee of the Legislative Assembly:

To inquire into and report on native land issues within the Province of Ontario.

The Committee shall:-

1. Conduct public hearings on this issue at Queen's Park and in at least 7 other Ontario communities;
2. Solicit input from Ontario citizens on their knowledge, experience and action proposals with respect to native land issues;
3. Present its report to the House, containing its observations, opinions and recommendations no later than the end of 2008. Filed on December 12, 2007.

10. Mrs. Witmer – That, in the opinion of this House, the Government of Ontario should protect the children and youth of this province from the harmful effects of second-hand smoke in automobiles by immediately implementing an effective province wide campaign to educate parents about the dangers of smoking in vehicles when a person who is less than 16 years of age is present. Filed on December 13, 2007.

11. Mr. Yakabuski – That, in the opinion of this House, the Government of Ontario should introduce legislation to exempt members of the Canadian Armed Forces from liability to pay the tax known as the Ontario Health Premium and that the Government immediately discontinue charging those members for that tax. Filed on December 13, 2007.

12. Ms. DiNovo – That, in the opinion of this House, the Ontario Government should support the Federal motion to urge the government of the People's Republic of China and representatives of Tibet's government in exile, to continue their dialogue in a forward looking manner that will lead to pragmatic solutions that respect the Chinese constitutional framework, the territorial integrity of China and fulfill the aspirations of the Tibetan people for a unified and genuinely autonomous Tibet. Filed on March 17, 2008.

13. Ms. DiNovo – That, in the opinion of this House, the Government of Ontario should immediately commence construction of not-for-profit rent geared to income housing units in order to keep its election promise of building 26,600 units; and begin to meet the housing needs of the 125,000 Ontarians on the waiting lists for affordable housing. Filed on March 17, 2008.

14. Ms. DiNovo – That, in the opinion of this House, the Government of Ontario should immediately end the clawback of the National Child Benefit Supplement from all families in Ontario. Filed on March 17, 2008.

15. Ms. DiNovo – That, in the opinion of this House, the powers of the Ontario Municipal Board be amended so that they are not able to undermine the authority of democratically elected city councils in decisions such as land use planning and others. Filed on March 17, 2008.

16. Ms. DiNovo – That, in the opinion of this House, seniors 65 years of age or over, have free access to Ontario funded art galleries and museums, and that the Ontario government reimburse these galleries and museums to compensate for the drop of revenue in providing this free access. Filed on March 17, 2008.
18. Ms. DiNovo – That, in the opinion of this House, 25% of all Ontario places of employment be inspected each year. Filed on March 17, 2008.
19. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should:
- a) Proclaim a regulation that implements an immediate temporary moratorium on issuing or renewing licences to operate Child Care Centres due to the potential consequences brought to light by present plans to acquire and consolidate ownership of existing for-profit operators;
  - b) Order a full policy review of child care in Ontario to ensure that future expansion only occurs in the not-for-profit sector upon ending the moratorium. Filed on March 17, 2008.
21. Mr. Wilson – That, in the opinion of this House, due to the potato industry in Ontario being subjected to the worst drought on record in 2007, affecting 30,000 out of 37,000 acres designated for potato growth, yielding the worst potato crop on record and presenting potato growers with huge losses, the Government of Ontario should instruct the Ministry of Agriculture to provide an ad hoc payment of \$12.8 million to the potato farmers of Ontario for relief from the drought of 2007. Filed on March 26, 2008.
26. Ms. MacLeod – That, in the opinion of this House, the Legislative Assembly should televise its proceedings online at [www.ontla.on.ca](http://www.ontla.on.ca); should make arrangements to have Bell Canada (including Satellite) televise proceedings (as Rogers Cable does) as part of their basic package; and should arrange with provincially funded cable stations TVO and TFO that daily Question Period is televised, in order to provide all residents of Ontario, particularly those in rural Ontario who do not have access to other cable sources, with access to the daily proceedings at Queen’s Park. Filed on April 9, 2008.
27. Ms. Jones – That, in the opinion of this House, the Government of Ontario should immediately expand the Foodland Ontario program to include a designation for organically grown products and expand their Foodland Ontario logo to include the word “organic” where appropriate. Filed on April 15, 2008.
30. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Training, Colleges and Universities should immediately make the necessary regulatory changes to accommodate the construction and manufacturing trades so that the ratio of journeyman trades-people to apprentices be one-to-one. Filed on April 21, 2008.
31. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should order a stand-alone inquest into the March 2006 murder of eight-year old Jared Osidacz, using the powers vested in the Minister of Community Safety and Correctional Services under Section 22 of The Coroners Act. Filed on April 21, 2008.
32. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should designate children’s mental health as a mandated provincial program to ensure adequate, stable and sustainable funding for the sector and the valued services it provides to Ontario’s children and youth. Filed on April 23, 2008.
34. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should proclaim the first full week from Monday to Sunday in May of each year as Children’s Mental Health Week. Filed on May 5, 2008.

35. Mrs. Witmer – That, in the opinion of this House, all Ontarians deserve to have timely access to a family doctor and that the Government of Ontario must take all steps possible to recruit new doctors to the province and retain those currently practicing here by making Ontario a more attractive place to practice medicine. Mr. Tabuns – That, in the opinion of this House, federal immigration legislation (Bill C-50) will have significant consequences for many families residing in this province, will substantially change current immigration legislation without proper consultation and will introduce substantial arbitrary elements into the administration of immigration processing, and should therefore be defeated by all parties in the Parliament of Canada. 38. Mr. Hillier – That, in the opinion of this House, in order to achieve an equitable, fair and stable provincial-municipal funding arrangement, a provincial-municipal funding Act and financing formula should be adopted, to provide long-term predictable and sustainable funding that allows our municipal partners the ability to provide the required services to their residents. Filed on June 3, 2008.

43. Mr. Lalonde – That, in the opinion of this House, June 3<sup>rd</sup> be declared "Glengarry-Prescott-Russell Day" at Queen's Park, and that the date may not be changed without the approval of the majority of the municipalities in the riding of Glengarry-Prescott-Russell. Should June 3<sup>rd</sup> fall on a Friday, Saturday, or Sunday, Glengarry-Prescott-Russell day at Queen's Park will take place the following Monday. Filed on June 3, 2008.

43. M. Filed on June 4, 2008.

47. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should, in support of Ontario’s farmers and growers, direct all provincial public institutions such as hospitals and health care facilities, schools, universities and colleges, government ministries, agencies, boards and commissions, etc., wherever possible, to purchase Ontario grown produce and flowers on occasions where such are required. Filed on June 17, 2008.

48. Ms. MacLeod – That, in the opinion of this House, the Legislative Assembly should proclaim the twentieth (20<sup>th</sup>) day of November each year as Provincial Day of the Child to coincide with International and National Children’s Day. Filed on September 22, 2008.

49. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should immediately approve Zenn cars and electric bicycles, as defined by Transport Canada in 2001, for permanent, legal use on Ontario roads, with the exception of 400-series highways. Filed on September 22, 2008.

53. Ms. Horwath – That, in the opinion of this House, the Ombudsman of Ontario should be granted oversight over child welfare and protection decisions so that families have a truly independent appeal mechanism available to investigate any concerns. Filed on October 6, 2008.

54. Ms. Horwath – That, in the opinion of this House, Autism Awareness Month should be officially recognized and publicly acknowledged in the Ontario Legislature in October of every year. Filed on October 6, 2008.

57. M<sup>me</sup> Gélinas – That, in the opinion of this House, simultaneous American Sign Language and langue des signes du Québec interpretation should be made available both within the Legislative Chamber and during committee hearings, and carried on the Ontario Parliamentary Broadcast of the Legislative Assembly and the proceedings of committees in the Amethyst Room in the ongoing effort to provide equal opportunity for all Ontarians to participate in the proceedings of this Assembly. Filed on October 22, 2008.

59. Ms. DiNovo – That, in the opinion of this House, we constitute an all party women’s committee to examine violence against women, its causes and our responses, and come up with an action plan for the Province of Ontario. Filed on October 29, 2008.

61. Mr. Colle – That, in the opinion of this House, the month of November should be proclaimed as Crohn’s and Colitis Awareness Month, in concert with the same designation by the Federal Health Minister in 2006, to recognize the courage of more than 200,000 Ontarians living with Crohn’s and Colitis and to encourage Ontarians to make finding a cure for inflammatory bowel disease a priority. Filed on October 29, 2008.

63. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should ensure that the Sarnia (Erie-St.Clair) Pathways program of in-school occupational therapy, physiotherapy and speech language pathology for children with disabilities is preserved, first and foremost, and strengthened over time through appropriate Ministry investments in these children’s services. Filed on November 18, 2008.

64. Mr. Barrett – That, in the opinion of this House, families adjacent to the Douglas Creek Estates subdivision in Caledonia must be offered adequate and appropriate compensation, beyond anything negotiated to date, for their subjection to social, economic and psychological distress since the illegal occupation by native activists on February 28, 2006; so-called OPP “no-go zones” must be eliminated and OPP patrols and protection restored to these zones, as well as to the subdivision; and the subdivision must be restored to its former status as a residential subdivision. Filed on November 19, 2008.

66. Mr. Moridi – That, in the opinion of this House, to celebrate the cultural diversity of this province, and to promote linguistic and cultural diversity and multilingualism, the Legislative Assembly of Ontario should proclaim the twenty first (21<sup>st</sup>) day of February as International Mother Language Day in Ontario. Filed on November 24, 2008.

67. Mr. Klees – That, in the opinion of this House, the Government of Ontario should introduce legislation to implement an automated insurance verification system that shall be designed with the goal of identifying motor vehicles that are being operated on Ontario roads without the required insurance coverage and shall provide accurate and current access to motor vehicle insurance coverage information for persons and agencies charged with the enforcement of motor vehicle insurance requirements, such that police officers can determine the validity of the insurance of a vehicle, and that license-issuing offices can have the ability to confirm in real time, that insurance coverage is valid; and that the Highway Traffic Act be amended to provide for the impoundment of the vehicle being driven by an uninsured motorist. 8. Consider the introduction of political parties and party financing at the municipal level.
9. Consider term limitations for elected municipal officials.
10. Consider models from other large municipalities in jurisdictions outside of Ontario.

That the Committee shall present, or if the House is not sitting, shall release by depositing with the Clerk of the House, its final report to the Assembly no later than the date provided in Standing Order 6(a)(ii) for the end of the Fall meeting period in 2009, except that if the Committee determines that more time is required to complete its final report, it may present or, if the House is not sitting, release by depositing with the Clerk of the House, an Interim Report in which an alternative date for the final report is established, which is not more than 90 days later.

That the Committee have the authority to meet at the call of the Chair, to call for persons, papers and things, to employ counsel and staff, and, as the Committee deems relevant to its terms of reference, to commission reports and adjourn from place to place; and

That in the event of, and notwithstanding, any prorogation of the House before the presentation of the Committee's final report, the Committee shall be deemed to be continued to the subsequent Session or Sessions and may continue to meet during any such prorogation; and

That the Committee may examine any other matter it deems relevant to its terms of reference; and

That the Committee be composed of four members from the Government, two from the Official Opposition and one from the Third Party. The membership of the Committee shall be filed with the Clerk of the Assembly by the whips of the recognized parties no later than Thursday, March 26, 2009. Filed on February 26, 2009.

79. Mr. Miller (Parry Sound–Muskoka) – That, in the opinion of this House, the McGuinty government should address the shortage of acute care beds in hospitals by providing alternatives for alternate level of care patients which include but are not limited to: an increase in long term care beds; an increase in assisted living beds for Ontarians with disabilities; improved access to living at home services; and increased hospice/palliative care beds. Filed on March 3, 2009.
