- Adequate funding of First Nations land use planning.
- Implementation of provisions that allow for the creation of a joint body that would be composed of equal numbers of First Nations members and Government of Ontario officials. This joint body would advise on the development, implementation, and coordination of land use planning in the Far North as well as perform any other advisory function to which the First Nations and Minister agree.
- Serious consideration of innovations similar to those included in Quebec's Plan du Nord such as a coordinating body for public investments in the Far North and an effective resource revenue sharing model which provides for the sharing of revenues between First Nations and the Ontario government on all resource related projects in the Far North; and

That new legislation be introduced to replace the existing Far North Act upon completion of this consultative process. Filed March 22, 2012.

Mr. Harris — Enquiry of the Ministry — Would the Minister of the Environment confirm whether the McGuinty government plans to continue its involvement with the Western Climate Initiative, and the implementation of a cap-and-trade system, now that 6 of the 11 provinces and states have pulled out of the Western Climate Initiative. February 21, 2012.

179. Mr. Harris — Enquiry of the Ministry — Would the Minister of the Environment provide a detailed accounting on the activities of the Green Belt Foundation, specifically, the name of every group or organization that has received funding since 2006 along with details on how these funds were used. February 21, 2012.

180. Mr. Harris — Enquiry of the Ministry — Would the Minister of the Environment provide details on the government's plan to deal with waste disposal in the event that the Michigan State Senate passes legislation currently under consideration to either limit or prohibit Canadian trash from Michigan landfills. Mr. Hudak — Enquiry of the Ministry — Would the Minister of Energy provide a detailed list of the 20,000 green jobs the government claims have been created as a result of the Green Energy and Green Economy Act, including the company, community and whether the jobs are temporary or permanent. 212. Mr. Shurman — Enquiry of the Ministry — Would the Minister of Finance please provide an estimate of the provincial deficit if the unemployment rate were 1% lower and in the event it were 1% higher. February 21, 2012.

213. Mr. Shurman — Enquiry of the Ministry — Would the Minister of Finance please provide an estimate of the provincial deficit if the size of the public sector were reduced by 2% and if it were increased by 2%. February 21, 2012.

214. Mrs. Munro — Enquiry of the Ministry — Would the Minister of Labour provide information about any discussions within the government to declare public transit an essential service in York Region. February 21, 2012.

215. Mrs. Munro — Enquiry of the Ministry — Would the Minister of Labour explain the rationale for declaring public transit in Toronto an essential service, but not public transit in York Region or other parts of Ontario. February 21, 2012.

216. Mrs. Munro — Enquiry of the Ministry — Would the Minister of Health and Long-Term Care explain what steps her Ministry has taken to end the discrimination in health and social service funding to growing areas such as York Region and Simcoe County. February 21, 2012.

Mr. McDonell — Enquiry of the Ministry — According to the Auditor General's report, a new information-sharing agreement between the Ministry of Consumer Services and the Electrical Safety Authority should have been in place by Fall 2011; will the Minister of Consumer Services confirm whether such an agreement has been signed and what its contents are.
