That, as an expression of the gratitude all Ontarians feel for their service, the government of Ontario is directed to establish the Lieutenant Governor’s Military Service Pin to recognize those Ontarians who have served, or are serving, in Canada’s Armed Forces. And further that the pin be designed to be worn on civilian clothing in order that those who have served may be recognized when they are not in uniform. Filed March 19, 2018.
2.
