That, in the opinion of this House, the Government of Ontario should amend the *Public Hospitals Act, 1990* to limit the maximum amount any Alternative Level of Care patient awaiting placement in a long-term care home can be charged to be equal to the co-pay in Ontario's long-term care homes.
